Action Alert - Support the Pooled Trust Notification Bill!

A new bill (S.1241/A.5175) has been introduced by the Legislature, which will help New Yorkers who do not meet the monthly income limit to qualify for Medicaid access CDPAP and other community-based long-term care services. This bill requires the New York State Department of Health (DOH) to notify new Medicaid enrollees that they can use a pooled trust.

Seniors and people with disabilities may use a Pooled Trust if their monthly income is higher than the limits to qualify for Medicaid. For those who wish to enroll in CDPAP or need home care, education about pooled trusts and Medicaid eligibility is critically important. Access to a pooled trust allows people to maximize their resources and their ability to live and thrive in the community through the use of long-term supports and services. Expanding access to pooled trusts saves the State money because it prevents Medicaid enrollees having to choose between their health care needs and other necessities such as food.

New York State should encourage and educate new Medicaid enrollees about Pooled Trusts. Many current CDPAP consumers would not be able to use the service without a pooled trust.

The Budget has been finalized and thanks to your advocacy, it contains a number of important pieces related to CDPA.

We asked you to do a lot this year. A trip to Albany, advocacy at home, another trip to Albany, testify at multiple hearings, and the list goes on. Your tireless advocacy showed real results in two BIG victories in the FY2018 budget: authorization of fiscal intermediaries by the Department of Health, and the inclusion of CDPA in home care worker wage parity law.

Fiscal Intermediary authorization: As CDPA continues to grow, so has the number of fiscal intermediaries (FIs). While growth can be a good thing, many new FIs have little understanding of the program, or the consumer responsibilities that go along with it. We have all heard horror stories of "fiscal intermediaries" forcing consumers to use workers selected by a third party, stealing competitors' private health information, and asking consumers to pay out of pocket if a personal assistant quits - to name just a few problems. This could only happen because the Department of Health had no way to police FIs. They did not even know how many there were!

Authorization will require all fiscal intermediaries in New York State to be screened by the Department of Health before being able to provide service. Applicants will have to demonstrate that they fulfill basic obligations defined in law and do not infringe on consumers' rights and responsibilities. This is a very important piece of law that will make sure consumers are empowered the way those who founded this program intended. It has been a priority of CDPAANYS for years, and we look forward to working with the Department of Health to implement it.

Wages and wage parity: CDPAANYS priorities have long included higher reimbursement and higher wages. To partially address this issue, the Senate and Assembly both sought to include CDPA in legislation commonly known as wage parity. Home care worker wage parity requires wages and benefits totaling \$15.09 in New York City and \$13.22 in Westchester and Long Island. The final Budget adds personal assistants in CDPA to home care worker wage parity, with an effective date of July 1.

While CDPAANYS supports wage parity, it must be properly funded and implemented in order to work. We will be paying close attention and working closely with the Governor's office and the Department of Health to implement wage parity. One immediate goal is to give more time to fiscal intermediaries to renegotiate contracts with managed care plans. A requirement for higher wages and benefits is meaningless if it results in FIs going out of business because the reimbursement is not there to pay for it.

CDPAANYS views wage parity as a strong first step in solving the statewide workforce crisis caused by low wages in home care and CDPA. This move means that the State has finally recognized that today's low pay is not sustainable, and is taking action to fix the problem.

We know this fight is far from over. We have not forgotten that this did not fix the workforce crisis in Upstate New York. CDPAANYS will continue advocacy to increase reimbursement and wages in the regions where wage parity law does not apply.

In the meantime, we want to THANK YOU for your hard work that has resulted in major change. You have spent hours on the phone with Assembly, Senate and Congress members, traveled hundreds of miles to Albany in the snow, and some of you have even been arrested.

Please look out for future information on what you can do to help ensure a strong future for the program.
