### Medicaid Is Under Attack Again!

The new version does even more to gut critical services for seniors and people with disabilities in Medicaid and private health insurance - including a new provision that makes it legal for insurance companies to discriminate against people with disabilities!

# Action Alert - Support the Pooled Trust Notification Bill!

A new bill (S.1241/A.5175)has been introduced by the Legislature, which will help New Yorkers who do not meet the monthly income limit to qualify for Medicaid access CDPA and other community-based long-term care services. This bill requires the New York State Department of Health (DOH) to notify new Medicaid enrollees that they can use a pooled trust.

Seniors and people with disabilities may use a Pooled Trust if their monthly income is higher than the limits to qualify for Medicaid. For those who wish to enroll in CDPA or need home care, education about pooled trusts and Medicaid eligibility is critically important. Access to a pooled trust allows people to maximize their resources and their ability to live and thrive in the community through the use of long-term supports and services. Expanding access to pooled trusts saves the State money because it prevents Medicaid enrollees having to choose between their health care needs and other necessities such as food.

New York State should encourage and educate new Medicaid enrollees about Pooled Trusts. Many current CDPA consumers would not be able to use the service without a pooled trust.

**ACTION:** Urge Your State Senators & Assembly Members to co-sponsor the Pooled Trust Notification Bill (S.1241/A.5175)!
