### **[PA Wages] WHY NOT US?** **CDPA workers deserve a raise too!**

For over two years, CDPAANYS has been making the case that personal assistants need a wage increase. We have argued that the artificially low cost demanded by Medicaid payments prevents consumers from being able to hire and keep a high quality workforce because personal assistants can not afford to live on the low wages the program offers.

Recently, Governor Cuomo convened a wage board to examine the wages paid to workers in the fast food industry and make recommendations as to whether or not the base wage in that sector should be \$15. CDPAANYS does not have anything against ANYONE who puts in a hard days work making enough money to live on, and supports this wage board; however, we note that in setting up this board, Governor Cuomo has paid attention to one group in the workforce, while ignoring another that he has direct control over through his ability to set Medicaid rates.

We must stand together and demand that the extremely hard work personal assistants perform needs to be recognized too. [Click here](#) to register for your local hearing now!

The wage board will be holding 4 hearings around the state. We are asking that you show up and make yourself visible to those making decisions. Do you have a shirt from Lobby Day? Wear it! Make signs that ask "What about us?" or "Where is my raise?" or "Medicaid must pay a living wage!" Maybe even "Working in Medicaid shouldn't put me on Medicaid!" Be creative! Come up with your own slogans and signs. Just don't be disrespectful to the fast food workers - we don't want to put down one group to get what we need. It's not the fast food workers fault that Medicaid doesn't pay more!

Also, we don't want to cause a ruckus. Sit in the audience with your shirts and signs. Grab a seat right up front! Don't yell. Don't cause a scene. The wage board has no power to give us what we want. Our goal is to get noticed. Make the Governor feel pressure and put this on his agenda.

## **HOUSE PANEL APPROVES EXTENSION OF INDEPENDENCE AT HOME DEMONSTRATION**

The Academy of Home Care Medicine applauds Chairman Ryan, Ranking Member Levin, Representatives Roskam and Thompson, and the entire House Ways and Means Committee for unanimously agreeing to support S.971, The Medicare Independence at Home Medical Practice Demonstration Improvement Act of 2015.

This two year extension of the Independence at Home (IAH) demonstration will provide the opportunity for the participating medical practices to continue to treat Medicare's highest cost chronically ill beneficiaries in their homes at lower cost while achieving better outcomes and a higher quality of life. The extension will also provide CMS further time to evaluate and report on the success of the Independence at Home (IAH) Demonstration. We anticipate that the Centers for Medicare and Medicaid Services (CMS) will soon announce the results from year one of the Demonstration. All expect those results to be quite positive.

The Independence at Home Demonstration illustrates that the cost of health care can be dramatically reduced for the 5% of patients with multiple chronic conditions who account for 50% or more of costs by providing home based primary care that produces better outcomes and preserves the patient's independence and dignity. Continuation of the IAH Demonstration, and eventual expansion to a Medicare benefit, will also encourage the nation's current and future medical workforce to pursue professionally rewarding careers in treating our nation's most complex chronically ill patients and reducing health care costs for any insurance plan. By design, the IAH Demonstration cares for Medicare beneficiaries who are some of the sickest and most isolated beneficiaries. Such a program is essential for the future of Medicare since nearly 10,000 beneficiaries are becoming eligible for Medicare every day and those with multiple chronic conditions are the fastest growing segment of the Medicare population.

We were especially pleased that Representatives Roskam and Thompson noted in the markup that IAH is unique among the Medicare demonstrations because it is targeted and fiscally responsible — there are no upfront payments and only

successful programs are rewarded. Representative Roskam observed that IAH reduces Medicare costs where they are the highest and improves health care for those in the greatest need. We also appreciate Representative Roskam recognizing the work of Academy President Dr. Tom Cornwell who has pioneered home - based primary care for his patients in the Chicago area. Representative Thompson also noted the similarly important pioneering work of Drs. Norman Vinn and Gresham Bayne, former President of the Academy, in Southern California.

The Academy and the IAH Coalition applauds the action taken by the Ways and Means Committee today to ensure that IAH remains in place for at least another two years. In the days ahead, we welcome final passage of this legislation on the House floor so that IAH Demonstration beneficiaries and others can be cared for where they most often prefer to be and where costs are often best be managed – in their homes with their families and loved ones. The Academy stands ready to work with Congress and in partnership with CMS to make the Independence at Home program accessible to all eligible high cost chronically ill Medicare beneficiary. The Independence at Home program is “targeted, immediate and proven” and serves the best interests of patients, practitioners and health plans.
