*Consumer Directed Services is not an Agency and makes no representation (positive or negative) regarding the appropriateness of any PCA Candidate, or the terms and conditions of any employment relationship. All employment and payment decisions are the exclusive responsibility of the Consumer.*

**Note: If you are seeking employment from a Consumer who is receiving their service authorization from a New York State Medicaid funded Consumer Directed Personal Assistance Program, the Consumer is permitted to consider your employment only if you can pass ALL of the following New York State reviews.**

1. You are an adult of at least 18 years of age.
2. The Consumer is not your spouse or (if the Consumer is younger than 21) is not your child.
3. You do not live in the home of the Consumer (unless their service requires it).
4. You are not the Designated Representative (Surrogate) of the Consumer.
5. You do not have any financial control over the Consumer.
6. Your information must pass a Federal and State Government Exclusion List Review.
- 7 You have a verifiable Social Security number and the qualified documents needed to prove that you are eligible to work in the United States.

**The State of New York also requires each Personal Care Assistant to complete a Health Assessment BEFORE you begin work.**

The Health Assessment includes:

- A basic physical exam - blood pressure, height, weight, etc.
- A TB (Tuberculosis) Screen (PPD) or a chest x-ray if the test is positive or if the test would not be appropriate
- A Measles and Rubella Screen or Vaccine
- A drug test of Urine (forensic toxicology)

**In addition to the above New York State requirements,** the municipality in which the Consumer lives may also impose additional health assessments or legal reviews. The Consumer Directed Personal Assistance Program your Consumer chooses will require the completion of a Memorandum of Understanding (Consumer / Personal Care Assistant Agreement) to clarify the employment relationship, and they may require other documents to help them effectively complete their role as the Consumers Fiscal Intermediary.

## *Call to Action – July 1 – Wage Parity Could end CDPAP*

*Fri, Jun 9, 2017 at 4:11 PM*

On **July 1**, Consumer Directed Personal Assistance (CDPA) will be included in wage parity. Wage parity means that plans now must calculate wages **and** benefits when calculating reimbursement. This means they will have to pay \$15.09 in NYC and \$13.22 in Long Island & Westchester.

Fiscal Intermediaries (FIs) cannot meet new wage parity requirements without additional funding from plans. Many plans have cut payments to FIs, which is why PA wages are low and overtime hours are being capped.

**If plans don't pay more to fiscal intermediaries, it will be the end of CDPA.**

**The CEO of Fidelis was paid \$1,818 *per hour* in 2015 - more than 120 times what a New York City PA will make once wage parity is in effect.**

1. **Call Governor Cuomo at 518-474-8390.**

4. Tell the Department of Health that your managed care plan is not paying its providers enough to meet new wage parity rules. Make sure they know wage parity is beginning July 1st.
5. **Call your managed care plan or MLTC and ask to file a grievance.**
6. Tell your plan they must pay for CDPA wage parity. They need to re-negotiate their contracts with fiscal intermediaries, so they can pay for wage parity. Remind them that wage parity is effective starting July 1st.

## ***Nonprofit insurer pulls out of Suffolk***

*Mon, May 22, 2017 at 1:40 PM*

Elderplan's HomeFirst, a managed long-term care plan, is pulling out of Suffolk County in the latest example of an insurer narrowing its geographic coverage for chronically ill and disabled members, the health plan confirmed on Friday. The decision "was driven by the difficulties we encountered effectively staffing and serving the needs of members across such an expansive geographic area," said a spokeswoman for the nonprofit MJHS, which runs Elderplan. The insurer will continue to cover members' services until they pick a new plan, she said.

The move follows the exit of another nonprofit managed long-term care plan, GuildNet, from Suffolk as well as Nassau and Westchester counties as of June 1. The two plans had covered 41% of the 5,735 managed long-term care enrollees in Suffolk County as of March. The state Department of Health is "closely tracking"

the transition of members in Suffolk County following the exits of GuildNet and Elderplan, a spokeswoman told Crain's.

There are still 10 plans offering coverage in the county, including Fidelis Care and North Shore-LIJ Health Plan. Earlier this month in response to GuildNet's exit, the department had said there was "ample capacity and choice" in the managed long-term care program. —J.L.

HRA has sent notices (see below) to members of CONCEPTS as a fee for service benefit informing them that starting 7/1/17, they will no longer be able to receive CDPAP through Concepts, and will have to select a new Fiscal Intermediary (FI)(this means an agency that provides CDPAP). The notice tells them that they have to pick a new FI by 5/26 or they will be auto-assigned to one.

These are people who are exempt or excluded from MLTC or managed care, generally because they are in a waiver program (OPWDD, NHTD, TBI, or in

hospice at the time they applied so were excluded from MLTC). There are reportedly about 400 affected consumers.

At this time, it is not clear whether there is any possibility to stay with Concepts, or to have more time to switch FI's. A history of CONCEPTS, which started the whole [CDPAP](http://www.wnylc.com/health/entry/40/) movement back in the 1980's can be found at the very end of this article - <http://www.wnylc.com/health/entry/40/>.
