Call Today in Support of Advanced Home Health Aide Legislation!

The Senate, Assembly, and the Governor's office have come to a three-way agreement on A.10707 (Glick)/S.8110 (LaValle). This bill creates a new home care position called the Advanced Home Health Aides, who can perform certain nursing tasks under the supervision of a Registered Nurse. The establishment of AHHAs would greatly expand the number of individuals who will be able to leave institutions and live safely in the community, primarily helping those who cannot safely utilize CDPA. CDPAANYS is supporting NYAIL and CDR, as well as many other advocates, in promoting this legislation.

2. Contact your State Senator by calling the Senate switchboard at [#518-455-2800](tel:518-455-2800) and ask to be connected to your Senator. Say "I am calling to urge Senator [your Senator's name] to support S.8110, which would allow advanced home health aides to perform certain advanced tasks under the supervision of a registered nurse. It will also allow many people with disabilities to leave institutions and move back into the community."

The establishment of AHHAs would greatly expand the number of individuals who will be able to leave institutions and live safely in the community. Many people with disabilities are currently stuck in nursing homes because they can not perform certain tasks independently, such as administering their own medication. These tasks are already being performed under the Consumer Directed Personal Attendant Program (CDPAP) for individuals who are able to self-direct. However, many people with disabilities are unable to self-direct and do not have someone who can do this for them. For these individuals, in order to live in the community, they must rely on family members for assistance. Many people with disabilities do not have family members who are able and willing to perform these tasks. By creating AHHAs, the State

will greatly alleviate burdens on these family members. It will also allow many more people to leave nursing homes and move back into the community.

CDPAANYS opposed similar legislation for years because it did not adequately protect consumers. It would have given a straight exemption from the nurse practice act to services run by an agency. We knew that the exemption CDPA has works because the consumer, not an agency, is in charge of supervising the services. This legislation represents a common sense compromise that expands services while still protecting consumers who cannot self-direct their own care.
