### **FLSA Decision: Court Rules In Favor of USDOL**

On Friday morning, the United States Court of Appeals for the District of Columbia upheld the federal Department of Labor's revisions to the "companionship exemption" under the Federal Labor Standards Act. *Home Care Association of America v. Weil*, (D.C. Circuit, Aug. 21, 2015). Those revisions remove the companionship exemption from federal minimum wage and overtime requirements for domestic workers employed by third-parties. In addition, those revisions greatly narrow the definition of "companionship services."

The federal Department of Labor in 2013 had significantly revised its FLSA regulations regarding the "companionship exemption." 78 Fed. Reg. 60,454 (Oct. 1, 2013). As revised, third-party employers can no longer claim that their workers are exempt from federal minimum wage and overtime rules, even if the workers are providing companionship services. 29 CFR § 552.109. In addition, the rule greatly narrowed the definition of "companionship services," so that if the worker is spending more than twenty percent of the worker's time on the "provision of care," the worker is deemed not to be providing "companionship services," whether the worker is directly employed by the family or by a third party employer. 29 CFR § 552.6(b). "Provision of care" means assistance with the activities of daily living and instrumental activities of daily living. 29 CFR § 552.6(b).

The Home Care Association of America challenged the revised regulation in federal court, contending that the Department of Labor had exceeded its authority in adopting the revised regulation. The District Court agreed, and invalidated the regulation. In doing so, the District Court enjoined the Department of Labor from enforcing the regulation. The Department of Labor appealed. The D.C. Circuit reversed the District Court, upholding the regulation in full.

Although the D.C. Circuit has reversed, it also effectively stayed the effect of its decision, granting the challengers seven days to file a petition with the Court for rehearing or a petition for rehearing by the full D.C. Circuit. For the short term, at least, the revised regulation is not in effect, and will not be until the D.C. Circuit takes further action.

If the regulation goes into effect, it will have significant impact upon home care agencies and the consumer directed personal assistance program.

### **Securing Basic Protections for Home Care Workers Is Crucial to Strengthening Critical, Growing Workforce**

Washington, DC – Caring Across Generations applauds today’s decision in the case Home Care Association, et al. v. Weil, et al. by the United States Court of Appeals for the District of Columbia Circuit. Resolving the lawsuit brought by for-profit home care associations against a new Department of Labor rule that would grant home care workers the right to minimum wage and overtime protections under the Fair Labor Standards Act, the panel of three judges ruled that the Department of Labor was acting within its authority when it updated FLSA regulations in recognition of the changing nature of homecare.

“This decision represents a major step forward, recognizing the value of care work in today’s economy,” said **Ai-jen Poo**, director of the National Domestic Workers Alliance and the co-director of the Caring Across Generations campaign. “Today’s ruling not only addresses a longstanding, shameful exclusion of professional caregivers from basic worker protections, it allows us to begin the real task at hand: strengthening this workforce for the enormous responsibility of caring for a growing aging population in America.”

“This is both a victory for home care providers — and for every family that may one day depend on the crucial support of a home care provider. The women and men who care for our aging moms, dads and grandparents will now be able to provide for their own families, too,” said **Sarita Gupta**, executive director of Jobs With Justice and the co-director of the Caring Across Generations campaign. “Extending minimum wage and overtime protections to this critical workforce is not just the right thing to do — now it’s the law of the land. This is a great first step toward creating the stable home care workforce we will need to meet our nation’s growing care needs and transforming home care work into high-quality jobs that are good for

America. Now it's up to states to ensure that as they implement this rule, no one is harmed in any way by cuts to home care programs or caps on hours."

"This ruling will mean the difference between constantly worrying about my bills and having a little breathing room. I've been a home care worker for 6 years, and I don't get any overtime – it's \$9 an hour no matter how many hours we work and no matter how many years we have been on the job," said **D'Rosa Davis**, a home care worker from Atlanta. "I love taking care of people, but my own family has been barely scraping by. Earning so little means I don't have the money to do much with my kids – and that breaks my heart. They are well cared for, but it would be so nice to be able to go on trips, see movies together and do other activities – basic things we should all be able to do. "

"Without the assistance of my attendants, I wouldn't be able to live independently in my home and stay in my community. They provide invaluable support that has allowed me to live on my own, get a graduate degree, and work as a marriage and family therapist," said **Nikki Brown-Booker of Oakland, California**. "They are all hard workers, but because they're paid through the state home care program, I have no say in their wages. I'm overjoyed that my home attendants will finally receive overtime pay for the long hours they work. I'd hate to lose any of my attendants. In order for this work to be sustainable, workers must make enough to be able to support themselves."

Home care is one of the fastest-growing occupations in the country, and is projected to add over one million new jobs to the US economy over the next decade. Yet despite the increasing demand and critical services these healthcare professionals provide, they earn poverty wages. The majority of home care workers are women of color and increasingly immigrants, and earn on average less than \$10/hour. More than half of all home care workers rely on public assistance to support their families, and one in two leave their jobs every year due to the poor working conditions.

## **Assistants need a pay hike, too**

Thousands of people in New York with disabilities like me who employ workers who help us live in our homes and the community use Consumer Directed Personal Assistance, a Medicaid program that allows a person with home care needs to employ personal assistants.

Fiscal intermediaries process our payroll and coordinate our employees' benefits on our behalf, and are reimbursed with Medicaid funds. CDPA saves state taxpayers tens of millions of dollars each year compared to licensed nursing agencies and other types of long-term care.

Recently, Gov. [Andrew Cuomo's Wage Board](#) recommended increasing the minimum wage for fast-food workers to \$15 per hour. No one who works full time should have to live in poverty or rely on government programs to survive, and fast-food workers are not the only employees who receive inadequate wages.

Our employees' value to us is priceless, because we need them in order to live freely in our communities. Each day, they do heavy lifting to transfer us in and out of bed, cook our food and feed us, get us dressed, brush our teeth, and wash our bodies, deal with urine, feces and other bodily functions and fluids most people find gross. Personal assistants sometimes perform skilled nursing tasks as well, such as wound care and catheter care.

But their wages have barely budged over the past several years. This is not because we don't feel they deserve adequate pay, nor because money is being kept for profits instead of going to workers. Most CDPA fiscal intermediaries operate with overhead and administrative costs of just 8-12 percent, an extremely low level in the health care world.

The reason we cannot pay our personal assistants more is inadequate Medicaid reimbursement rates. These rates are set by the state; either directly in cases where the county administers the program or indirectly through the state's premium rates to managed care plans. According to the state [Department of Health](#), the average Medicaid reimbursement rate for most CDPA fiscal intermediaries across the state has actually decreased over the past several years, while the cost of seemingly everything else has risen.

Ten years ago, we could offer our personal assistants a decent, competitive wage. Today, throughout the state, some consumers can only pay their personal assistants minimum wage. We are not aware of anyone who can even come close to paying their workers \$15 per hour. It's not uncommon for a personal assistant to be on Medicaid, food stamps or other public benefits.

Recruiting and retaining quality employees has become increasingly difficult because the wages have not kept up with inflation. Trying to compete with an industry paying \$15 per hour will make it harder. Lack of staff will place our health and safety in jeopardy, and increase our risk of hospitalization or significantly more expensive institutional care.

Cuomo and the Legislature must increase CDPA reimbursement rates so that we can pay our workers more. Cuomo's website essentially says he intends to try raising the minimum wage of every worker in the state. That would be great for our employees and for the sake of our freedom and independence. But to raise our employees' wages, we do not simply need a decree or a law. We need the state to provide the necessary funding to pay for raises.

We hope Cuomo sees this as a great opportunity to lead by example. If the state starts to require fast-food companies to put more of their money into the pay of their low-income workers, Cuomo could also make sure the state puts more of its money into the pay of low-income workers in state-funded programs, like our personal assistants.

## **MLTC Policy 15.05: Clarification on Requirements for Consumer Directed Personal Assistance Service (CDPAS) Fiscal Intermediaries**

Office of Health Insurance Programs: Division of Long Term Care

Date of Issuance: August 14, 2015

The purpose of this policy document is to clarify the conditions under which a managed care organization (MCO) may sign an administrative agreement with a Fiscal Intermediary (FI) for the administration of the Consumer Directed Personal Assistance Service (CDPAS).

For organizations interested in becoming an FI for a MLTC plan, the process is as follows:

- The organization must apply for a discrete Medicaid provider ID number that is solely associated with its FI by completing the New York State Medicaid Enrollment Form available at the following link:

[https://www.emedny.org/info/ProviderEnrollment/personal\\_care/index.aspx](https://www.emedny.org/info/ProviderEnrollment/personal_care/index.aspx)

Securing a contract with a LDSS is not necessary when contracting with a MCO. However, MCOs that want to become an FI must also establish a separate line of business with the appropriate firewalls in place to ensure that the FI operates separately from the MCO.

All FIs and those interested in becoming one must be able to meet all of the requirements as outlined in the CDPAS regulations at 18 NYCRR §505.28. Those requirements include, but are not limited to:

- processing each consumer directed personal assistant's wages and benefits, including establishing the amount of each assistant's wages; processing all income tax and other required wage withholdings; and complying with worker's compensation, disability and unemployment insurance requirements;
- ensuring that the health status of each consumer directed personal assistant is assessed prior to service delivery pursuant to 10 NYCRR §766.11(c) and (d) or any successor regulation;
- monitoring the consumer's or, if applicable, the consumer's designated representative's continuing ability to fulfill the consumer's responsibilities under the program and promptly notifying all appropriate parties of any circumstance that may affect the consumer's or, if applicable, the consumer's designated representative's ability to fulfill such responsibilities;
- entering into a Department approved administrative agreement with the health plan or contract with the LDSS for the provision of CDPAS; and
- ensuring that the FI is fulfilling the responsibilities to the consumer as outlined in 18 NYCRR §505.28(g).

Please review all existing FI administrative agreements to ensure that all of the above criteria, including a Medicaid provider ID number, is met. Any FI that does not meet these requirements will be granted a 120 day grace period from the date of issuance to achieve compliance.
