Comments: I am a 33-year-old male looking for someone to fill a personal care/home health assistant role in New York City, working between two and three days per week. I will need help with the daily task of waking up, showering, and eating, and the evening tasks of eating and going to sleep. This is a live-in position that is a supplement to my regular assistant care and I'm looking for someone to start as soon as possible.

I suffered a snowboarding accident that has left me paralyzed with no use of my legs, limited use of my arms, and no use of my hands. I get around using a motorized wheelchair, and I am able to use cell phones and my computer through a headset.

This has been a frustrating injury, as my brain is fine but I am considerably restricted physically. I have just recently returned to working (with much of the time working from home). I work for a sportswear company in New York and also have side projects that I consult on. Considering my injury, I am a fairly social person and go out often with friends to social and cultural events.

Because of my physical state, I am looking for an assistant who can help me get into bed and go to sleep at night, turn me once in the middle of the night, and help me wake up and get ready in the morning.

A typical routine will have you coming to meet me around 10 or 11 PM at the apartment. You help me go from my wheelchair to the bed, help me get undressed and set me up for sleeping.

I weigh approximately 170 pounds and am 6 feet tall, so this is something either a man or woman can do, but there is some physical effort required here. The best way for me to be transferred is through use of a Hoyer lift, which I have.

I will need you to stay over, and turn me once in the night. There is a second bed in my room. This often occurs at 3 AM and takes about five minutes.

I wake up around 8 AM to begin my day. I will need you to help me with going to the bathroom. This is done through a digital stimulation/enema process while I sit in a shower chair. If this is not something you are familiar with, I'm able to train you. The process typically takes about 30 to 40 minutes.

From there, I will need someone to help me take a shower. There is a waterproof wheelchair that we use, it's fairly straightforward once you've seen it done. Since I don't have use of my hands, I will need you to wash me off in the shower.

Then, I am rolled into the bedroom where I am put back into bed and dressed. After being dressed, I will ask you to help me with stretching before I am put back into my wheelchair.

The final element of the routine will have you clean the bathroom and make the bedroom up.

During the day, the assistance I require will be variable, it will range from helping me with meals, light housecleaning, and at times, walking with me to work to make sure I get there safely. Other tasks include helping me empty my catheter bag once or twice during the day, fairly straightforward.

I am enrolled in the Medicaid CDPAP program, so payments will come through that at the HHA.

I encourage you to reach out to me with some information about yourself so that we can speak and potentially set up an interview.

DOL Home Care Rule Upheld in Court

In Texas, personal assistants and ADAPT activists march together to try to get the pay of all attendants raised to \$10. Nationally, personal assistants are paid an average of \$9.57. With the ruling upholding the DOL Home Care Rule, they are now eligible for overtime. But for many, this may actually mean a cut in hours.

Nearly 2 million home health care workers are set to receive overtime and minimum wage protections as a federal appeals court has upheld the Department of Labor's Home Care Rule. While some in the disability community are outraged at the August 21 ruling, others have expressed relief.

The court's decision will complicate attendant care for those who require more than 40 hours a week, as most agencies will cap their workers' hours in order to avoid paying overtime, says Bruce Darling, Center for Disability Rights CEO. "Individuals with disabilities will need to hire multiple people ... assuming they can find multiple people."

Darling is frustrated with the Obama administration's failure to fully ensure that people with disabilities get the care they need. "We're calling on Health and Human Services to assure that states are paying out Medicaid rates that will be adequate money to pay the overtime," he says. "It's very clear to us that the result of these rules without additional Medicaid funding will be the institutionalization of people with disabilities."

Rahnee Patrick, an advocate with Chicago ADAPT, supports the Court's decision, as she considers the companionship exemption to be a discriminatory policy that has long overlooked the importance of in-home caregivers. "I'm pleased the decision is there because I think it brings value to work that people are doing in the home," she says.

She has received personal assistance for years and says people with disabilities need access to care in the community. Making sure the feds cover the gap for paying overtime is important for advocates like Patrick as well as directors of provider agencies like Darling. "I'm going to be involved in making sure that reimbursement rates are available for people," says Patrick.

DOL's Final Rule Upheld By D.C. Court Of Appeals

BREAKING NEWS: The D.C. Court of Appeals ruled today that the US Department of Labor's ("DOL") Final Rule on the Application of the Fair Labor Standards Act to Domestic Service (the "Final Rule") is valid, because it is "grounded in a reasonable interpretation of the statute (FLSA) and is neither arbitrary nor capricious." Under the Final Rule, home care agency workers are no longer covered by the FLSA's companionship services exemption or its live-in domestic worker exemption. This decision is of serious concern to the home care industry. Whether the decision will be appealed to the U.S. Supreme Court remains to be seen.

What Questions Do Home Care Agencies Need To Have Answered?

1. **When will the change in the law be considered effective?** The Final Rule was initially to be effective January 1, 2015, before it was invalidated by the district court. The D.C. Court of Appeals has reversed the district court, and remanded for entry of summary judgment in favor of the DOL. How will the District Court's earlier decisions, or a delay in issuing its decision on remand, delay the effective date? What position will the DOL take on the effective date?
2. **When will the DOL begin to enforce the Final Rule?** When the Final Rule was originally issued, the DOL said it would delay enforcement for six months from the effective date or until June 30, 2015, and for the remainder of 2015, would exercise prosecutorial discretion in determining whether to bring enforcement actions. Will the DOL still provide for a meaningful transition period?
3. **How does validation of the Final Rule affect private attorney lawsuits and class actions?** Agencies are now obligated to pay time and one half the worker's regular rate of pay for hours worked over 40 in a workweek. If a worker receives a base rate and a higher rate for certain hours (e.g. weekend), calculation of a worker's overtime rate will be more difficult because it requires a weighted blending of the two rates to provide the regular rate of pay for that week. Employers who do not comply may be targeted by plaintiff's lawyers.
4. **How does validation of the Final Rule affect enforcement actions by the NYS Department of Labor?** The Final Rule effectively eliminates the differing treatment of workers under New York law based on whether they are employed by agencies or directly by households. Formerly, under the NYS Domestic Workers Bill of Rights, for-profit agency home care workers who qualified as "companions" under federal law only had to be paid overtime at one and one half the NYS minimum rate of pay. Now all agencies, for-

profit and not-for-profit, must pay home care workers overtime at one and one-half times the individual worker's regular rate of pay.

5. **What effect does the Final Rule have on the "hours worked" rules applicable to the home care industry?** Is there a difference in the treatment of "live-in" workers versus "sleep-in" workers? What type of written agreements with 24 hour case workers must be entered into? Is it a "duty-free" hour if the worker is required to remain on-call on the premises? How must sleep time and travel time be handled?

FLSA Decision: **Court Rules In Favor of USDOL**

On Friday morning, the United States Court of Appeals for the District of Columbia upheld the federal Department of Labor's revisions to the "companionship exemption" under the Federal Labor Standards Act. *Home Care Association of America v. Weil*, (D.C. Circuit, Aug. 21, 2015). Those revisions remove the companionship exemption from federal minimum wage and overtime requirements for domestic workers employed by third-parties. In addition, those revisions greatly narrow the definition of "companionship services."

The federal Department of Labor in 2013 had significantly revised its FLSA regulations regarding the "companionship exemption." 78 Fed. Reg. 60,454 (Oct. 1, 2013). As revised, third-party employers can no longer claim that their workers are exempt from federal minimum wage and overtime rules, even if the workers are providing companionship services. 29 CFR § 552.109. In addition, the rule greatly narrowed the definition of "companionship services," so that if the worker is spending more than twenty percent of the worker's time on the "provision of care," the worker is deemed not to be providing "companionship services," whether the worker is directly employed by the family or by a third party employer. 29 CFR § 552.6(b). "Provision of care" means assistance with the activities of daily living and instrumental activities of daily living. 29 CFR § 552.6(b).

The Home Care Association of America challenged the revised regulation in federal court, contending that the Department of Labor had exceeded its authority in adopting the revised regulation. The District Court agreed, and invalidated the regulation. In doing so, the District Court enjoined the Department of Labor from enforcing the regulation. The Department of Labor appealed. The D.C. Circuit reversed the District Court, upholding the regulation in full.

Although the D.C. Circuit has reversed, it also effectively stayed the effect of its decision, granting the challengers seven days to file a petition with the Court for rehearing or a petition for rehearing by the full D.C. Circuit. For the short term, at least, the revised regulation is not in effect, and will not be until the D.C. Circuit takes further action.

If the regulation goes into effect, it will have significant impact upon home care agencies and the consumer directed personal assistance program.

Resolving the lawsuit brought by for-profit home care associations against a new Department of Labor rule that would grant home care workers the right to minimum wage and overtime protections under the Fair Labor Standards Act, the panel of three judges ruled that the Department of Labor was acting within its authority when it updated FLSA regulations in recognition of the changing nature of homecare.

“This decision represents a major step forward, recognizing the value of care work in today’s economy,” said **Ai-jen Poo**, director of the National Domestic Workers Alliance and the co-director of the Caring Across Generations campaign. “Today’s ruling not only addresses a longstanding, shameful exclusion of professional caregivers from basic worker protections, it allows us to begin the real task at hand: strengthening this workforce for the enormous responsibility of caring for a growing aging population in America.”

“This is both a victory for home care providers — and for every family that may one day depend on the crucial support of a home care provider. The women and men who care for our aging moms, dads and grandparents will now be able to provide for their own families, too,” said **Sarita Gupta**, executive director of Jobs With Justice and the co-director of the Caring Across Generations campaign. “Extending minimum wage and overtime protections to this critical workforce is not just the right thing to do — now it’s the law of the land. This is a great first step toward creating the stable home care workforce we will need to meet our nation’s growing care needs and transforming home care work into high-quality jobs that are good for America. Now it’s up to states to ensure that as they implement this rule, no one is harmed in any way by cuts to home care programs or caps on hours.”

“This ruling will mean the difference between constantly worrying about my bills and having a little breathing room. I’ve been a home care worker for 6 years, and I don’t get any overtime –

it's \$9 an hour no matter how many hours we work and no matter how many years we have been on the job," said **D'Rosa Davis**, a home care worker from Atlanta. "I love taking care of people, but my own family has been barely scraping by. Earning so little means I don't have the money to do much with my kids – and that breaks my heart. They are well cared for, but it would be so nice to be able to go on trips, see movies together and do other activities – basic things we should all be able to do. "

"Without the assistance of my attendants, I wouldn't be able to live independently in my home and stay in my community. They provide invaluable support that has allowed me to live on my own, get a graduate degree, and work as a marriage and family therapist," said **Nikki Brown-Booker of Oakland, California**. "They are all hard workers, but because they're paid through the state home care program, I have no say in their wages. I'm overjoyed that my home attendants will finally receive overtime pay for the long hours they work. I'd hate to lose any of my attendants. In order for this work to be sustainable, workers must make enough to be able to support themselves."

Home care is one of the fastest-growing occupations in the country, and is projected to add over one million new jobs to the US economy over the next decade. Yet despite the increasing demand and critical services these healthcare professionals provide, they earn poverty wages. The majority of home care workers are women of color and increasingly immigrants, and earn on average less than \$10/hour. More than half of all home care workers rely on public assistance to support their families, and one in two leave their jobs every year due to the poor working conditions.
