The candidate must be willing to communicate with me by phone regarding job related issues. I require punctuality. This means that the PCA must be able to arrive on time when I call upon her to work, and they need to consider traveling time to insure that they will arrive when needed.

I am authorized 25 hours a week - 5 hours a day, Monday through Friday. I am connected with Concepts of Independence, which means that I hire the person and she gets paid by Medicaid through Concepts. To speed the hiring process the candidate **MUST** already be signed up with Concepts

My requirements include, cooking, cleaning, laundry, escorting me places such as the doctor's office or other places that I may need to go. One of the special requirements I have is reading mail as I can't do it myself. Also, given my need to go to appointments, candidates with a car will get special consideration.

As I said above, I am looking for a back up PCA, therefore I need someone who I can call upon with short notice as I may find out that my full time PCA cannot work either the day before or the same day. I know this is probably difficult but I can only work with the circumstances as they are presented to me.

#### **Governor Cuomo Releases Olmstead Plan Sent: 10/11/2013 7:02:32 P.M. Eastern Daylight Time**

Today, Governor Cuomo released the state's historic Olmstead Plan. The administration's commitment to fulfill this obligation was long awaited by our community, as it meets the standard set by many other states and directed through a

federal mandate to ensure integrated settings for persons with disabilities. The plan—attached below through web link—details how the state will pursue this process.

In 1999, the Supreme Court upheld the Olmstead court case and held that public entities must provide community-based services to persons with disabilities when a) such services are appropriate, b) the affected persons do not oppose community-based treatment, and c) community-based services can be reasonably accommodated, taking into account the resources available to the public entity and the needs of others who are receiving disability services from the entity.

New York's Olmstead Plan details the policy, fiscal, and service resources necessary to adequately transition persons with disabilities into the most integrated setting possible. It reflects not only institutional care in settings such as nursing homes and adult homes, but also the issue of sheltered workshops, transportation, and the criminal justice system, and how they pertain to equal rights in community based settings.

NYAPRS is active on the Most Integrated Setting Coordinating Council (MISCC), a body that has continuously advocated for effective implementation of the Olmstead mandate, as well as the DOH Adult Home Advisory Board. We will continue these and relative efforts to ensure that each member of our community receives appropriate treatment in the least restrictive setting possible, in order to achieve full livelihood and recovery.
