EVERYTHING OLD IS NEW AGAIN - As a former Program Director of a Consumer Directed Personal Assistance Program I had the opportunity to participate in the workshop "[Autonomy or Abandonment: Changing Perspectives on Delegation](#)" (<http://aspe.hhs.gov/daltcp/reports/autoabes.htm>, which was convened on October 24 and 25, 1996 to discuss the issue of Nurse Delegation, a strategy that was being bantered about as a "new" cost saving initiative. As a participant, I was able to express support for the position that had been developed in the State of New York in 1992 with the support of representatives from both the disabled community and the professional nursing associations. In 1992 the State of New York adopted an approach that empowered Consumers while avoiding the quagmire of Nurse Delegation by amending the exemption clause of the [New York State Nurse Practice Act](#) (http://law.justia.com/codes/new-york/2006/education/edn06908_6908.html).

Unfortunately, it is apparent that this issue has reemerged - **New York State Nurses Association - MEMORANDUM OF CONCERN** - *Medicaid Redesign Team Proposal #200 Short Title: Change in scope of practice for mid-level providers to promote efficiency and lower Medicaid costs Description: Expand the scope of practice for RNs, LPNs, and home health aides to improve access to services and decrease associated costs in delivering services Reforms the state's supervision and orientation regulations for home health aides and personal care workers, Permits nurses/patients (under their*

scope of practice/practice exemption) to orient/direct HHAs and PC workers to provide "nursing care" as is currently allowed in the Consumer Directed Personal Assistant Program.

Between 1992 and 2011 there is one basis similarity. In both situations, there is an ongoing effort to reduce Medicaid costs and the program regulators are willing consider systems that will reduce the quality of service as a means of achieving this objective. As was the case in 1992, it is my hope that the State of New York will once again see the wisdom of maintaining a separation between the rights and responsibilities associated with the Consumer Directed Personal Assistance Program and those associated with the conventional medical home care model. In this case I support the nurse's contention that blurring this line would jeopardize their professional standing and endanger consumers who would be subject to the provision of substandard care. I would further argue that the blurring of this line would also jeopardize one of the clear underpinnings of the Consumer Directed Personal Assistance Program as a unique service delivery program in which the Consumer or their Surrogate has accepted the full and independent responsibility for the management of their own service delivery program.

Within the Consumer Directed Personal Assistance Program, the Consumer can hire as many PCA's as they deem necessary to accommodate their lifestyle within the hours authorized by the Local Department of Social Services.
The services required by the Consumer can include basic Housekeeping, Personal Care (bathing, dressing, toileting, assistance with mobility, meal preparation, meal assistance, etc.) and a variety of higher level Consumer trained and supervised nursing level services ventilator support, tracheal suctioning, dressing care, etc.).

12-HOUR NIGHT AND 24-HOUR SLEEP-IN SCHEDULES
AND PEOPLE WITH VENTILATOR EXPERIENCE.
