# **Articles Related to the CDPAP**

#### Will states seek Medicaid demonstration waivers to cut costs?

November 7, 2011

States are submitting or considering submitting 1115 Medicaid waiver plans as a way to control their Medicaid budgets, according to the latest Steve Gold Information Bulletin. Gold raises the concern that people with disabilities, especially those with severe disabilities, will not have their needs adequately met through these waivers and may risk being placed in an instituation.

Section 1115 of the Social Security Act allows the Secretary of the Department of Health and Human Services to suspend certain federal laws or regulations that govern programs authorized by Medicaid and SCHIP as research and demonstration projects. According to Gold, the structure of some 1115 waivers are statewide, comprehensive demonstrations that affect the majority of people who receive Medicaid while others are more limited in scope, such as "cash and counseling" waivers. Gold warns that these resemble block grants and most state governors and their Medicaid directors are looking for any way to control their Medicaid budgets and may consider the 1115 waiver process as a way to make this happen.

The Newsletter is submitted to hundreds of Home Care Consumers and Advocates. Consumers are People with Disabilities or Seniors who independently hire, train and supervise the Home Care Worker (Personal Care Assistant - PCA) of their choice. Although a few Consumers pay for their own home care services, most Consumers pay for their services through Medicaid funded Consumer Directed Personal Assistance Programs. Within the Consumer Directed Personal Assistance Program, the Consumer can hire as many PCA's as they deem necessary to accommodate their lifestyle within the hours authorized by the Local Department of Social Services.

The services required by the Consumer can include basic Housekeeping, Personal Care (bathing, dressing, toileting, assistance with mobility, meal preparation, meal assistance, etc.) and a variety of higher level Consumer trained and supervised nursing level services ventilator support, tracheal suctioning, dressing care, etc.).

NOTE: THERE IS A GREAT DEMAND FOR 12-HOUR NIGHT AND 24-HOUR SLEEP-IN SCHEDULES AND PEOPLE WITH VENTILATOR EXPERIENCE.
